Questions and Answers

1. Can you include a five (5) year CIP farming plan?

Answer: The Farmland Conservation Project is a multi-year plan to implement improvements as recommended by the airport's farm manager. The current improvement plan and map designates the proposed projects by farm tract, see Exhibit 1. Farmland improvements may include nutrient run-off measures such as the planting of prairie strips, tree grubbing, and reshaping drainage ditches to stop water being forced out into the farm field; and installing drainage tile on land that has been wet in the spring, shortening the planting and growing seasons, and reducing crop yields. As part of the Airport Commission's strategic plan and ongoing conservation efforts, the Commission adopted Resolution 12-03-19, see Exhibit 2. The 5-Year Farmland Conservation budget totals \$944,700.




EXHIBIT 2

RESOLUTION NO. 12-03-19

WHEREAS, in April 2016, the Cedar Rapids Airport Commission adopted a comprehensive strategic plan to serve as a guide for future of the Eastern Iowa Airport by outlining a shared purpose, core values, and goals to ensure continued organizational success;

WHEREAS, environmental stewardship was identified as a core value to ensure the responsible management of environmental resources in all current and future projects to the benefit of the Eastern lowa community;

WHEREAS, the Eastern Iowa Airport is one of the largest single farmland owner/managers in Linn County located at the highest elevation of the Cedar River and Iowa River watershed;

WHEREAS, the Cedar Rapids Airport Commission has implemented soil conservation and nutrient management programs on the Eastern lowa Airport farmland consisting of, but not limited to: improving, reshaping, and reseeding the grass waterway systems; adding additional field drainage tile; no fall tillage or application of fall fertilizer; no-till planting of soybeans crop; cost share with farm operator on the planting of cover crops; participating with lowa State University in the planting of prairie strips in conjunction with the STRIPS (Science-based Trials of Row crops Integrated with Prairie Strips) program; and participating with the University of Iowa Biomass renewable energy program in the planting of Miscanthus grass;

WHEREAS, the Cedar Rapids Airport Commission continues to manage the Eastern Iowa Airport farmland for maximum productivity and minimize the soil and nutrient losses;

NOW, THEREFORE BE IT RESOLVED that the Cedar Rapids Airport Commission implements full cover crops and no-till tillage system for all farmland at the Eastern Iowa Airport effective March 1, 2020; and that the Airport Director is hereby authorized and directed to give notice to the farmland operators of said full cover crops and no-till tillage system; and

BE IT FURTHER RESOLVED, by the Cedar Rapids Airport Commission to terminate all Farm Leases effective March 1, 2020 and that the Airport Director is hereby authorized and directed to give notice to the farmland operators of said lease termination.
