LOCATED AT THE EASTERN IOWA AIRPORT, CEDAR RAPIDS, IOWA

The Cedar Rapids Airport Commission is advertising for quotations for a proposed public improvement project to be known as 2019 Airfield Pavement Marking Replacement described as removal and placement of airfield thermoplastic pavement markings and located at The Eastern Iowa Airport, Cedar Rapids, Iowa.

DESCRIPTION OF WORK

The Work generally consists of the removal and replacement of airfield preformed thermoplastic surface hold sign markings and pavement markings at The Eastern Iowa Airport in Cedar Rapids, Iowa.

TYPE OF QUOTE

Quotations shall be on a unit price basis.

CONTRACT TIME INFORMATION

The Cedar Rapids Airport Commission has established a contract performance time, from the date of the Notice-to-Proceed, following approval of the properly executed contract documents, of 28 Calendar Days. Furthermore, the Work shall be complete by September 6, 2019.

All project work shall be substantially completed within the stated timeframe. This project is subject to liquidated damages as prescribed within the project manual.

QUOTE OPENING TIME, DATE AND LOCATION

The Eastern Iowa Airport will receive quotations at the office of the Airport Director until 2:30 p.m. on May 14, 2019. Quotations received after this time will not be opened. The quotations will be opened and read aloud at 2:30 p.m. on May 14, 2019 at the Commission Room of The Eastern Iowa Airport, 2515 Arthur Collins Parkway SW, in the City of Cedar Rapids, Iowa.

CONTRACT TERMS

The bidder should not include sales tax in the quote. Items included in the Project are exempt from State of Iowa and Local Option Sales and Use Taxes. Contractor is responsible for obtaining the exemption or for applying for reimbursement for such taxes paid.

The successful bidder will be required to submit a Certification of Non-segregated Facilities and to notify prospective subcontractors of the requirement for such certification where the subcontract exceeds \$10,000.00.
