

NOTICE TO BIDDERS
OF ADVERTISEMENT FOR SEALED BIDS FOR PROPOSED PUBLIC IMPROVEMENT
TO BE KNOWN AS LIPPISCH PLACE ROADWAY IMPROVEMENTS DESCRIBED AS
REHABILITATION OF ROADWAY AND PARKING PAVEMENT AND LOCATED AT THE EASTERN
IOWA AIRPORT, CEDAR RAPIDS, IOWA

The Cedar Rapids Airport Commission is advertising for sealed bids for a proposed public improvement project to be known as Lippisch Place Roadway Improvements described as rehabilitation of roadway and parking pavement and associated work and located at The Eastern Iowa Airport, Cedar Rapids, Iowa.

DESCRIPTION OF WORK

The Work generally consists of pavement milling, pavement rubblization, Asphalt Cement Concrete overlay, subdrain installation, replacement of existing parking and roadway lighting, subgrade stabilization, and pavement markings at The Eastern Iowa Airport in Cedar Rapids, Iowa.

TYPE OF BID

Bids shall be on a unit price basis.

CONTRACT TIME INFORMATION

The Cedar Rapids Airport Commission has established a contract performance time, from the date indicated in the Notice-to-Proceed, following approval of properly executed contract documents, of:

Base Bid: complete within 20 Working Days and complete by September 27, 2019;

Base Bid Roadway Lighting: complete by February 28, 2020;

Bid Alternate 1, if selected; complete within 40 Working Days and complete by September 27, 2019;

Bid Alternate 1, if selected, Parking Lot lighting: complete by February 28, 2020.

Final Completion: 30 Calendar Days following Roadway and Parking Lot Lighting completion date.

All project work shall be substantially completed within the stated timeframe. This project is subject to liquidated damages as prescribed within the project manual.

BID OPENING TIME, DATE AND LOCATION

The Eastern Iowa Airport will receive sealed bids at the office of the Airport Director until 2:00 p.m. on June 13, 2019. Bids received after this time will not be opened. The bids will be opened and read aloud at 2:00 p.m. on June 13, 2019 at the Commission Room of The Eastern Iowa Airport, 2515 Arthur Collins Parkway SW, in the City of Cedar Rapids, Iowa.

CONTRACT TERMS

The bidder should not include sales tax in the bid. Items included in the Project are exempt from State of Iowa and Local Option Sales and Use Taxes. Contractor is responsible for obtaining the exemption or for applying for reimbursement for such taxes paid.

The successful bidder will be required to submit a Certification of Non-segregated Facilities and to notify prospective subcontractors of the requirement for such certification where the subcontract exceeds \$10,000.00.
