## **General Statement of Duties**

Provides labor, maintenance assistance and heavy equipment operation to the Airport Maintenance Department.

#### **Distinguishing Features of the Class**

Works under general supervision or independently.

#### **Examples of Essential Work ( Illustrative Only)**

Receives work assignments from lead worker;

Performs snow removal on all airport surfaces using snow blowers and sand/chemical spreaders as well as large heavy equipment such as: runway plow, high-speed broom and/or tow broom, runway snow blower, dump trucks and particle matter spreaders, liquid runway chemical deicer applicator, end loaders. Assists in equipment maintenance:

Performs all work duties and activities in accordance with Airport policies, procedures and safety practices;

Attends work regularly at the designated place and time;

Performs related work as required.

## **Required Knowledge and Abilities**

Ability to react quickly when operating or working around equipment in an uncontrolled environment. Ability to operate or use the following equipment and tools: push, self-propelled and riding mowers; weed wacker; edger; safety equipment; hand tools and department vehicles. Ability to work under supervision or independently.

## Acceptable Experience and Training

Labor and mower/equipment operator experience preferred.

Airport airside movement area training, knowledge, and experience preferred.

Any equivalent combination of experience and training which provides the knowledge and abilities necessary to perform the work.

#### **Required Special Qualifications**

Valid Iowa Drivers License required for airside assignment; or Valid Iowa Class B CDL required for landside assignment. Pass and maintain security background check as per Transportation Security Regulations.

#### **Essential Physical Abilities**
