

**NOTICE TO BIDDERS
OF ADVERTISEMENT FOR SEALED BIDS FOR PROPOSED PUBLIC IMPROVEMENT
TO BE KNOWN AS 2024 PARKING LOT PAVEMENT MAINTENANCE
AND LOCATED AT
THE EASTERN IOWA AIRPORT, CEDAR RAPIDS, IOWA**

The Cedar Rapids Airport Commission is advertising for sealed bids for a proposed public improvement project to be known as 2024 Parking Lot Pavement Maintenance described as parking lot and roadway pavement maintenance and associated work and located at the Eastern Iowa Airport, Cedar Rapids, Iowa.

DESCRIPTION OF WORK

The Work generally consists of parking lot and roadway pavement maintenance including, PCC and HMA patching, cleaning and filling PCC pavement joints and PCC and HMA cracks, emulsified asphalt slurry seal, waterborne and thermoplastic pavement markings and traffic control at the Eastern Iowa Airport in Cedar Rapids, Iowa.

TYPE OF BID

Bids shall be on a unit price basis.

CONTRACT TIME INFORMATION

The Cedar Rapids Airport Commission anticipates the Notice-to-Proceed to be issued no earlier than following approval of properly executed contract documents, and has established a contract performance time of:

Rental Car Ready Lot:

- Early Start Date: July 22, 2024
- Late Start Date: May 12, 2025
- Complete within 45 Calendar Days

Rental Car Facility Lot:

- Late Start Date: May 27, 2025
- Complete within 30 Calendar Days

Short Term and Long Term Parking Lot:

- Late Start Date: May 12, 2025
- Complete within 35 Calendar Days

Corporate Hangars Parking Lot:

- Complete by August 9, 2024 or complete between May 12, 2025 and June 30, 2025
- Complete within 21 Calendar Days

Final Completion: 45 Calendar Days following Substantial Completion date.

All project work shall be substantially completed within the stated timeframe. This project is subject to liquidated damages as prescribed within the project manual.

BID OPENING TIME, DATE AND LOCATION

The Eastern Iowa Airport will receive sealed bids at the office of the Airport Director until 2:00 p.m. on June 13, 2024. Bids received after this time will not be opened. The bids will be opened and read aloud at 2:00 p.m. on June 13, 2024 at the Commission Room of The Eastern Iowa Airport, 2515 Arthur Collins Parkway SW, in the City of Cedar Rapids, Iowa.

CONTRACT TERMS

The bidder should not include sales tax in the bid. Items included in the Project are exempt from State of Iowa and Local Option Sales and Use Taxes. Contractor is responsible for obtaining the exemption or for applying for reimbursement for such taxes paid.

The successful bidder will be required to submit a Certification of Non-segregated Facilities and to notify prospective subcontractors of the requirement for such certification where the subcontract exceeds \$10,000.00.
